SCW Has Changed Its By-Laws for \$25 Payment by April 1

Players will pay by 4/1 or earlier, whereas before, they could pay as late as October. This will allow the people who put the teams together in the fall to know in advance who will play. Under the old system, it was difficult to put teams together at the last minute, and then there were no-shows to boot. The Rec

Center has also asked the SCW Club to operate on a calendar year instead of the old fiscal year from October to September.
