2. NO TIME CLOCK, PLAY 7 INNINGS, 8 INNINGS IN CASE OF A TIE
3. PLAYERS CAN ONLY SUB AS A COURTESY RUNNER ONCE PER INNING
4. COURTESY RUNNERS FROM HOME MUST STOP AT FIRST BASE.
5. MANAGERS ARRANGE FOR SUBS FROM THE SUB LIST OR AS STATED IN THE N. L. RULES
6. A PLAYER MAY SUBSTITUTE ONLY TWO TIMES EACH WEEK AND ONLY ONCE FOR THE SAME TEAM
7. NO INFIELD FLY RULE
8. 4 RUN LIMIT PER INNING, 7TH INNING NO LIMIT

Rule change for session

1 RUN MERCY RULE

If the visiting team is ahead by one (1) or more at the end of six innings, the home team will clear the bases and continue to bat in the top of the 7th inning. If home team does not tie or go ahead, the game is over. In the event the home team ties or goes ahead the visiting team will get last at bat.

The VISITING TEAM is always listed first and they occupy the 1st base dugout.

1st-game - HOME TEAM OF GAME 2 SUPPLIES OFFICIATING GROUP. (2UMPIRES, 1 SCOREKEEPER)

2nd game & each game there after the VISITING TEAM of the previous game supplies the officiating group.

HOME TEAM for the 1st game prepares the field

HOME TEAM for the last game secures the field.
