George noted that a new SCW FLAG will be placed on the Flag Pole by the Rec Center. Yard Sale by Softball Club has been put on hold at this time. Possible date...Nov 2010.

George requested \$13 per bunting for field fence draping. President Bob Peck Approved Request.

Batter’s Box system needs to be replaced. Cost is \$150.00 per mat (mats are 3 yrs old). Approved by Bob Peck.
