MERCY RULE

3 RUN - If visiting team is ahead 3 or more runs at the end of 6 innings, home team clears the bases & bats again, if home team doesn't tie or go ahead game over. In the event home team ties or goes ahead, visiting team gets last at bat.

12 RUN - If either team is ahead by 12 or more runs at the end of 6 innings
GAME OVER

The visiting team is listed FIRST, and occupies 1st base

1st game - HOME TEAM of game two (2) supplies officiating crew (2 umpires and 2 scorekeepers)

2nd game and each game thereafter for the day VISITING TEAM of the previous game supplies the officiating crew.

HOME TEAM - 1st game prepares the field

HOME TEAM - Last game secures the field
